5. All transportation & equipments to be used in project/work shall be arranged by the agency at their own cost. Water and electricity will be provided on payment basis as per market rate.
6. Site clearance after completion of work will be done by contractor.

TERMS AND CONDITIONS

1. The scope of the work Dismantling & Re-Laying Of Synthetic Surface of Basket Ball Court Ten Layers at AIMT, Greater Noida and as per directions.
2. You are requested to give your **TECHNICAL BIDS** and **COMMERCIAL BIDS** separately in two different sealed envelopes. The format for **Technical bid** is attached as **Appendix 'A'** and for **Commercial Bid** is attached as **Appendix 'B'**.
3. The envelopes should be clearly marked **TECHNICAL/ COMMERCIAL BIDS** for work **Dismantling & Re-Laying Of Synthetic Surface of Basket Ball Court Ten Layers at AIMT, Greater Noida**. The Technical Bid will be opened first and only if found valid & suitable then the commercial bid would be opened. The decision of the Board shall be final & binding on all and no representations in this regard will be entertained.
4. **Earnest Money deposit (EMD)**: All technical Bids must be accompanied with a Demand Draft (No Cheque/ Cash) of Rs 25,000/- (Rupees twenty five Thousand only) in favour of the Army Institute of Management & Technology which is refundable on non-acceptance of the tender. Earnest money of selected vendor will be kept as security money and will only be refunded after completion of project. In case of vendor/firm failed to complete the project within stipulated period security money will be confiscated.
5. **Performance Bank Guarantee**:- Performance Bank Guarantee @ 10% of the total cost of project will be deposited with the College on completion of work/project. Payment will be made on receipt of PBG. Period of PBG will be 12 months.
6. **Time for Completion of Project**:- Time for completion of the project will be specified in the supply/work order. In no case period of work would be more than 60 days from the date of receipt of the work order.
7. **Payment Terms**:- Payments will be made through Cheque /NEFT in the name of Firm, after completion of work / supply of stores and checking by the Board of Officers and endorsing certificate that the quality of material used is of standard quality, as per specification / description and is satisfactory.
8. **Warranty**:- The following Warranty will from part of the contract:-
 - (a) The contractor / supplier warrants for a minimum period of **Two year** from the date of execution of work / supply of stores.
 - (b) If within the period of warranty, any item/portion of the work is found defective, the same will be rectified immediately free of charge.
9. **Delay Penalties/Liquidity Damages**. In case of delay in completion of work / supply of stores by 60 days, penalty @ 0.5% of the total cost of project shall be levied per week.
10. **Bid Validity**. Bid shall remain valid for 90 (Ninety) days from the date of opening of tender.
11. **Acceptance of Tenders**: The tenders / quotations are to be submitted separately as Technical Bid and Commercial Bid.
12. **Opening of Tenders**: Date and Time for opening of technical bids mentioned on tender form and commercial bids shall be communicated separately. It is advised that one of your representatives is present accordingly. Commercial bid will be opened after approval of Technical Bids.

13. **Scope of work:-** The contractor shall provide all labor, materials, equipment and supervision required for the Dismantling & Re-Laying of Synthetic Surface of Basket Ball Court
14. **Dispute Resolution:** In the event of any dispute or difference between the parties hereto, such dispute or difference shall be resolved amicably by mutual consultation. Final deciding authority will be the Chairman, Delhi Cantt
15. All materials brought to site shall be subject to the approval of the College. In case if any substandard quality/ unapproved material are used, the same shall be removed by the agency at his own expense.
16. **Site Clearance.** The contractor will be responsible for removing all the debris (Malwa) from the site immediate on completion of work. Payment will only be made on clearance of site.
17. **Line Marking:-** Application of standard basketball court marking as per international standards.
18. **Curing and inspection:-** Ensuring proper curing time for the surface and final inspection for defects
19. **Technical Specifications:** Synthetic Surface Material:
