The parties hereto shall keep strictly confidential all technical, business and other information including but not limited to that which may be disclosed or confided to it by the other in the course of the performance of its duties and obligations under this arrangement.

Nothing contained herein shall be deemed to create any association, partnership, joint venture or relationship of principal and agent or, master and servant or, employer and employee, between the parties hereto or any affiliates or subsidiaries thereof or, between the employees, officers, personnel, agents of either party and the other party.

Complaint resolution-

The parties hereto shall address the issues, concerns and complaints through mutual discussion. consultation and cooperation.
