  - (e) QD Fund.
  - (f) Offrs Mess/JCOs Club Accts.
  - (g) ECHS Accts (Held with ECHS Est only).
- 2. The procedure for conduct of quarterly audit bd of accts will be as under:-
  - (a) Quarterly Audit Bd of accts in respect of all units of this fmns will be carried out by a standing bd as given at **Appx A** att to this letter.
  - (b) One Lt Col/ Maj as Presiding Offr will be detailed by the auditing unit and two members (one offr and JCO) will be provided by the unit whose accts are to be audited as listed in **Appx A** to this letter.
  - (c) Quarterly audit bd proceeding duly completed will be fwd to this HQ for countersignatures of the Fmn Cdr. Quarterly audit bd for QE Mar, Jun, Sep and Dec to be completed by 10<sup>th</sup> of Apr, Jul, Oct and Jan respectively.
- 4. Units will be responsible to info this HQ by 10<sup>th</sup> of Apr, Jul, Oct and Jan in case Presiding Offrs (as per Appx) detailed to carry out the quarterly audit bd have failed to carry out the audit.
- All Presiding Offrs of the bds listed at Appx will fwd a cert, duly signed as given below by 15<sup>th</sup> of Apr, Jul, Oct and Jan respectively on completion of audit of all units and not in piecemeal:-

- 6. All Presiding Offrs of bds will be resp to inform this HQ by 10<sup>th</sup> of Apr, Jul, Oct and Jan details of units which have not produced their accts for audit without fail. No representation regards to the change of composition of the bd will be accepted.
- 7. The bd will ensure that their responsibilities do not cease with comparing cash balance with that in the cash book as on the date of audit. A thorugh audit of accts should be carried out and the bd will ensure the following:-

- (a) The accts have been updated till date.
- (b) All receipts upto the time of audit have been entered in the cash book. Omissions if any are properly explained.
- (c) Tfr from one acct of another is properly carried out and an entry in the receiving fund acct is made.
- (d) Scrutiny of bank statement and its reconciliation with cash book balance and respective accts have been tallied.
- (e) Verification of oral statement of the person incharge of accts with supporting docu.
- (f) Justification for retention of heavy cash balance in hand.
- (g) All items purchased are taken on ledger charge and are accounted for.
- (h) Prior sanction of CFA has been obtained in case purchases are made beyond the financial limits laid down as per existing orders.
- 8. Instructions on audit of Regt Fund Accts as laid down in Spl Western Comd order No 1/S/83 will be adhered to Appx to WCO 1/S/83 will also be att in duplicate with the bd proceedings.
- 9. Presiding Offr for quarterly audit bd and the units that are being audited will ensure the implementation of the fwg pts:-
  - (a) Unit of the Presiding Offr and the Members will be mentioned under their signature in the bd proceedings.
  - (b) Only two copies of the bd proceedings will be tagged separately in order to facilitate the return of one copy after the proceedings have been countersigned.
  - (c) In case of any obs made by the bd, the CO unit will give his clarification on the remarks coln in the bd proceedings.

  - (m) Bank reconciliation statement, if reqd.
  - (n) BOO and the acct holder must sign on the balance sheet.

### (o) Public Fund Accts

- (i) The Public Funds credited but not utilized during the FY need to be returned to the Govt treasury by way of MRO and bal made Nil on 31<sup>st</sup> Mar every yr. Holding of public funds beyond 31<sup>st</sup> Mar may invite serious audit objn.
- (ii) Screen shot of FP MIS & PCDA WC expdr/ billing report alongwith MER and qrtly audit reports wrt Public Funds must be reqd in every QE.
- 11. COs/OCs unit will ensure that thorough check of quarterly audit bd proceedings are carried out and its correctness verified in all respect before sending to this HQ for countersignatures of the Fmn Cdr.
- 12. This letter will be in effect from **QE Mar 2022.** This letter also supersedes all previous letters issued regarding detailment of Presiding offr and members on the subject matter.
